Release and Waiver of Liability, Assumption of Risk, Parental Consent, and Indemnity Agreement

I acknowledge that participating in activities on a working farm may contain inherent risks of injury to my child. I accept that being involved with a working farm involves certain inherent risks. These risk include but not limited to, the risk of injury, insect bites/stings, over exertion or environmental conditions. Despite these risk, I choose to allow my child to engage in these activities. I know of no physical limitations that should keep my child from engaging in these activities. I hereby personally assume all risk, whether foreseen or unforeseen, for any harm, injury or damage that may befall my child as a participate. I hereby release, on behalf of myself, my child, my heirs, executor, administrators, and assigns, b&b farm Lincolnton LLC, directors, employees, and volunteers, from any and all liability for any injury, death, or other damages to me, my child, my family, heirs, or assigns that may occur as a result of me/my child's participation in these activities, a result of product liability, or the negligence of any party, including b&b farm Lincolnton LLC, whether passive or active.

I further agree, on behalf of myself, my child, my heirs, executors, administrators, and assigns, that I will defend, indemnify, and hold b&b farms Lincolnton LLC and it's directors, employees and volunteers harmless against any claims, demands, and causes of action, including court cost and attorney fees, directly and indirectly arising from and actions or proceedings brought by or prosecuted for my benefit contrary to this release.

Under NC state law, there is no liability for an injury to, or death of, a participant in an activity conducted at this location if such injury or death results from inherent risk of activity. Inherent risk include, among others, risk of injury inherent to the land, and animal as well as potential for you to act in a negligent manner that may contribute to injury or death.

Chapter 99E-32 of the NC General Statues

During farm camp if an emergency arrises involving physical wellbeing of child I give consent to b&b farm Lincolnton LLC staff to use best judgement in rendering medical aid and/or ambulance services for minor/child. I agree to be responsible for all cost associated with treatment.

I HAVE READ THIS RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, PARENTAL CONSENT, AND INDEMNITY AGREEMENT. I UNDERSTAND THAT BY SIGNING IT, I GIVE UP SUBSTANTIAL RIGHTS I AND/OR THE MINOR WOULD OTHERWISE HAVE TO RECOVER DAMAGES FOR LOSSES OR INJURY, EVEN IF OCCASIONED BY THE RELEASED PARTIES' FAULT, AND SIGNIR FREELY, VOLUNTARY AND WITHOUT INDUCEMENT OR DURESS.
